**CALL TO ORDER:** President Kim Thurman called the meeting to order at 1:39 p.m. via Zoom; a quorum was established. Kim welcomed everyone to our September Members' meeting.

We also have submitted a grant for hybrid equipment for our meeting room. This grant requires that we need to pay one-half of the cost of this equipment. Rich's hours will count. ***Motion: Anne Billeter moved that we post the 2022 Proposed Budget on the bulletin board in the Library and also post it on-line so members can review it before the October meeting. Marilyn Ayres seconded. Motion passed.***

**MEMBER SHARING.** Rich Miles stated that his husband recently discovered that his third great grandfather, Moses Quesenberry, is buried in Ashland and that he had no headstone. He died in 1911, outliving his siblings, children, grandchildren and great-grandchildren! There will be a ceremony on September 30 to place a headstone on his grave.

**BOARD ACTIONS.** Kim Thurman noted that Director Summaries are shown on the agenda. Kim noted that our Finance Director has resigned. Kim Thurman, Rich Miles, and Katie Haugse are working on the grant.

**PROGRAM.** Barbara Halvorsen introduced the program for today, "New Member Shoutout." Nancy Keely, Monica Krise, and Judy Ryden. These three have all joined RVGS since 2019.
