Call to Order

Treasurer's Report

Treasurer Kim Thurman reported that the numbers reflect that we were more dramatically "in the hole" than previously reported due to an unrealized loss on investment in the endowment fund of \$9,804.75. This is because of fluctuations in the stock market.

Kim also noted that if our balance in Banner Bank gets too high, it may be transferred to designated funds, capital improvement, or the endowment fund. The Finance Committee will meet in the near future to determine recommendations for the Board to approve.

Mr. Peterson presented a program detailing fascinating historic tales of the Rogue Valley. The growth of Lithia Motors, Jim Parsons' building mousetrap bases from scrap lumber, tombstones at the Oak Knoll golf course, the penning of *Raggedy Ann and Andy*_and *Lolita*, the initial rejection of the Carnegie Libraries (and then acceptance) due to Carnegie's association with "robber barons" and JFK's visits to the Rogue Valley and subsequent Grand Marshal of the Pear Blossom Parade were just a few of the best kept secrets Mr. Peterson discussed.
